Commercial Use - End User License Agreement

Your access to and utilization of the Fonts are governed by the stipulations outlined herein, collectively constituting a binding legal agreement between you (the "Licensee") and the Licensor (hereinafter the "License"). By installing, accessing, and/or utilizing the Fonts, the Licensee signifies having thoroughly reviewed, comprehended, and agreed to be bound by the terms and conditions of this License.

Should you require further clarification regarding the terms and conditions outlined herein, or if your specific situation necessitates the inclusion of additional wording, you are cordially invited to engage in discussions with the Licensor. The Licensor, an independent design studio committed to customer satisfaction, is always receptive to exploring innovative approaches to enhance its service offerings. The Licensor firmly believes that Fonts encumbered by excessive restrictions ultimately hinder user satisfaction and strives to maintain licensing flexibility to accommodate a diverse range of workflows.

1. INTELLECTUAL PROPERTY

The Licensee unequivocally acknowledges that the Fonts, trademarks, copyrights, including the copyright of the typeface, and any other intellectual property rights associated therewith are the sole and exclusive property of the Licensor and are protected by copyright and other applicable intellectual property laws. The Licensor retains sole ownership of all title, copyright, and other intellectual property rights in the Fonts. The Licensee acquires no ownership rights in the Fonts whatsoever.

2. LICENSE AND ACCESS AUTHORIZATIONS

- **2.1.** License Grant In consideration of the Licensee's express acceptance of the terms and conditions of this License, the Licensor hereby grants to the Licensee a non-transferable, worldwide, non-exclusive right to install, access, and utilize the Fonts.
- **2.2.** Weights The Licensee's rights to utilize the Fonts are expressly limited to the specific font weights purchased at the time of checkout.
- 2.3. Desktop License To utilize a Font in the creation of digital images (JPG, GIF, PNG, etc.), printed artwork such as flyers or physical objects, or any other product intended for sale by the Licensee or their clients, a Desktop License must be acquired. With a Desktop License, the Licensee is granted the right to install and use the Font, as specified during the checkout process, on a designated number of workstations, including notebooks, laptop computers, or desktop computers. This License also authorizes the use of the Fonts to produce non-digital 3-dimensional shapes, rubber stamps, or scrapbooking alphabets that can be sold by the Licensee or their clients.
- 2.4. Web License To embed a Font on a website, the Licensee must acquire a Web License for each distinct domain or subdomain where the Font will be implemented. The Web License is

subject to a specified monthly page view limit, as indicated during the checkout process. Embedding the entire character set as fonts within electronic documents is prohibited unless explicit written consent has been granted by the Licensor.

- 2.5. App License To utilize a Font within a mobile application, web application, or video game, the Licensee must obtain an App License for each distinct application where the Font will be incorporated. The App License is subject to a specified monthly active user limit, as stipulated during the checkout process.
- 2.6. Broadcast License To utilize a Font within a television advertisement campaign, the Licensee must acquire a Broadcast License for each individual broadcast where the Font will be featured. The Broadcast License is subject to a specified impression limit. Due to the dynamic nature of Broadcast License usage, Licensees are encouraged to contact info.showup33@gmail.com to discuss their specific requirements.
- 2.7. Social Media License To utilize a Font across multiple social media profiles, the Licensee may acquire a single Social Media License. This license permits the use of the Font on all social media platforms where the Licensee maintains a presence. However, the total number of combined followers across all platforms is subject to a specified limit, as indicated during the checkout process.
- 2.8. Logo License To incorporate a Font into a company's logo, the Licensee must acquire a Logo License for each distinct corporation where the Font will be employed within the logo. The cost of the Logo License is contingent upon the number of employees at the corporation, as outlined during the checkout process. The Logo License grants the Licensee the right to utilize the logo across all platforms (i.e., print materials, websites, social media, etc.) without the requirement for additional licenses.
- 2.9. License Upgrade In the event that the Licensee's usage of a Font surpasses the limits of the initially purchased license, the Licensee may contact info.showup33@gmail.com to initiate a license upgrade. The upgrade fee will be determined by the difference between the cost of the required license and the fees paid upon the initial purchase.
- 2.10. Internal Usage The Licensee may install the Fonts for internal use by its employees and may also grant access to the Fonts to its partners and collaborators, provided that the Licensee has acquired an appropriate license for the intended usage. The Licensee bears the responsibility of ensuring that its employees, partners, and collaborators adhere to the terms of this License. The Licensee further acknowledges that it is liable for any violations of this License committed by its employees, partners, or collaborators.

3. CONDITIONS OF USE

- **3.1. General Conditions** The Licensee is granted a non-exclusive, non-transferable license to use the Fonts solely in accordance with the terms and conditions of this License. The Licensee may not:
 - Use the Fonts for any purpose not expressly permitted by this License.
 - Share the Fonts with third parties.
 - Use the Fonts in a way that infringes any applicable laws or regulations.
 - Choose the wrong License for its intended use.

The Licensee acknowledges that the Licensor retains all ownership rights in the Fonts. Any violation of these terms may result in the termination of the License and may subject the Licensee to legal action.

- **3.2.** Software Compatibility The Fonts are compatible with a wide range of software applications, including mainstream programs such as Microsoft Office and the Adobe Suite. The Licensee may utilize the Fonts with any compatible software that facilitates their intended use.
- **3.3. Prepress Authorization** The Licensee may send the Fonts to third-party printing services for specific printing projects. The Licensee must ensure that the fonts are removed from the printing service provider's systems upon completion of the project. The Licensee is responsible for the use of the Fonts by any third party to whom they have granted access.
- **3.4.** Corporate Identity and Branding The Licensee may utilize the Fonts to create visual elements that contribute to its corporate identity or branding initiatives. This encompasses a broad range of materials, including letterheads, business cards, business forms, banners, film titles, and tiein products. rights. The Licensee is prohibited from directly modifying the Font files, changing the Font name, or utilizing the modified outlines to create a new Font. The Licensor's design fees for modifications may vary depending on the complexity of the work and the availability of designers.

- **3.7.** Prohibited Uses The Licensee shall not engage in any of the following prohibited uses of the Fonts: The Licensee is prohibited from distributing, uploading, or reselling the Fonts without authorization.
- **3.8.** Reserved Uses The Licensee is expressly granted the right to utilize the Fonts solely for the purposes explicitly outlined in this License. Any use of the Fonts that extends beyond the scope of the permitted uses is strictly prohibited. Should the Licensee desire to utilize the Fonts in a manner not expressly covered by this License, the Licensee must seek prior written authorization from the Licensor.
- **3.9. Veracity of Information** The Licensee hereby affirms that all information provided through the Licensor's website is accurate and truthful in nature. The Licensee assumes full responsibility for the veracity of the information submitted and acknowledges that any misrepresentation of facts may result in legal consequences.
- **3.10.** Consequences of Breach The Licensor maintains the right to refuse future purchases from Licensees who have demonstrated a history of breaching the terms of their License. Additionally, the Licensee bears full liability for twice the total costs incurred as a result of their unauthorized use of the Fonts. This penalty serves as a deterrent against future violations of the License Agreement.

4. PAYMENT TERMS

- **4.1.** Payment Authorization The Licensee hereby grants the Licensor the authority to process payments in accordance with the selected license options, at the prevailing rates applicable at the time of purchase. This includes any additional fees, such as taxes, duties, and/or transaction fees, as may be applicable. The Licensor retains the right to modify its rates at any time without prior notice.
- **4.2.** Refund Policy Payment for access to the Fonts is made upfront upon invoicing. Sales are final, and no refunds or credits will be issued by the Licensor for payments made for access to the Fonts. This policy applies even if the Licensee wishes to downgrade or cancel their License.
- **4.3.** Pricing and Currency All prices displayed on the Licensor's website are denominated in United States Dollars (USD). The Licensee bears the sole responsibility for any currency exchange rate

discrepancies that may arise upon payment processing through their credit card provider.

5. QUALITY AND SUPPORT

- 5.1. Quality Assurance and Replacement Policy All Font files undergo rigorous testing procedures before being made available for licensing. However, if any issues arise with the Fonts or their associated files, the Licensee will be provided with a satisfactory replacement of functioning files. To initiate a replacement request, the Licensee must furnish their order number and/or purchase receipt.
- 5.2. Technical Support The Licensor offers a complimentary technical support service to Licensees for a period of ninety (90) days following the Font purchase date. This support service encompasses access to the Licensor's support staff and assistance with any support or maintenance inquiries, including those related to font usage and troubleshooting. Communications can be conducted in Indonesian or English via email to info.showup33@gmail. com. The Licensor's support team aims to respond to inquiries within an average of three (3) business days. Support staff are available via email at info.showup33@gmail.com from Monday to Friday, between 9 AM and 5 PM.

6. PERSONAL INFORMATION

- 6.1. Data Ownership The Licensee maintains ownership of all data submitted to the Licensor unless otherwise expressly stated. This includes, but is not limited to, visit data, session data, impression data, click-through data, click-stream data, and any statistical or other analysis, information, or data derived from such data (collectively referred to as "Licensee Data").
- 6.2. Personal Data To access specific sections of the website or purchase a Font, the Licensee is required to provide their name, email address, and other potentially personally identifiable information (collectively referred to as "Personal Data"). Additionally, for Font purchases, the Licensee may be asked to provide supplementary data, such as credit card information, to facilitate payment processing. The Licensor does not retain the Licensee's payment information. The Licensee grants their consent for the collection, utilization, and sharing of their Personal Data for the purposes of enhancing and maintaining the website and Fonts, as well as bolstering the website's security. This consent is deemed to be granted upon the Licensee's acceptance of this License. 7. GENERAL PROVISIONS

7.1. Age Requirement – The Licensee hereby declares that they are at least eighteen (18) years of age prior to proceeding with a purchase through the Licensor's website. Alternatively, the

- 7.2. Font Modifications The Licensor reserves the right to modify the Fonts, at its sole discretion, at any time and without prior notice to the Licensee. These modifications may include, but are not limited to, updating or enhancing the fonts, correcting errors, and addressing any bugs or compatibility issues. The Licensee acknowledges and accepts that these modifications may affect the appearance or functionality of the Fonts.
- **7.3.** Non-compliance and Termination Without detracting from the preceding provisions, the Licensor may, at its sole discretion, terminate the Licensee's access to the Fonts if the Licensee fails to comply with the terms of this License. Such termination may occur without prior notice to the Licensee.
- 7.4. Limited Liability The Fonts are designed and intended for use within the standard and conventional parameters of font usage. The Licensor can only guarantee and support their functionality as fonts within that standard and conventional scope of use and cannot be held responsible or liable for any incidental damages arising from any unauthorized or unconventional use of the Fonts.
- 7.5. Entire Agreement This License, with respect to the Fonts, constitutes the entirety of the agreement made between the Licensee and the Licensor. No other agreements, representations, or warranties, oral or written, shall apply to this License.
- **7.6.** License Modification The Licensor reserves the right to modify this License at any time, without prior notice to Licensees that have previously purchased fonts. The version of this License that is applicable to each font is the one that was in effect on the date and time that the Licensee ordered the specific font.
- 7.7. Governing Law and Jurisdiction This License is governed by the laws of the province of Aceh, Indonesia, as applicable. Any dispute arising out of or in connection with this License shall be exclusively resolved in accordance with the laws of the province of Aceh, Indonesia, by a competent court with jurisdiction in the city of Banda Aceh, province of Aceh, Indonesia.
- **7.8.** Font in Use The Licensor retains the right to showcase examples of designs using the Fonts in their portfolio as a demonstration of their typographic expertise. Such examples may include, but are not limited to, website mockups, application screenshots, or print advertisements.
